We are beginning to make preparations for the 23rd Annual Casey's Kids Fun Run & Health Expo, which benefits economically disadvantaged students in Keller ISD, and we need your help. With over 35,000 students in Keller ISD, of which more than 25 percent are economically disadvantaged, many students benefit each year from Casey's Kids.

Casey's Kids started in 1997 when Janie Casey, a former counselor in Keller ISD, discovered that a student was limiting the number of school days attended per week due to a lack of clothing. It was this student's need that led to Ms. Casey's mission to find a way to fund the clothing needs of students in need district-wide. Named in Janie's honor, the Casey's Kids Fun Run began as an effort to provide clothing and has now expanded to include other items such as school supplies and household needs. This year we have expanded even further by partnering with the Keller ISD Health Expo to increase awareness of Casey's Kids and healthy choices, as well as to provide various free health screenings and information to our district.
