- Volunteers will be available to assist unloading/set up and loading.
- **We will be anticipating 1000+ participants in the event.**
- Vendors will have the opportunity to interact with the participants and visitors to provide information about their companies and services. There will be a bingo card raffle to encourage visiting with Vendors. Completed raffle cards will be eligible for a prize drawing to take place after the event. **We encourage Vendors to supply a bingo card raffle item to help encourage event traffic.**
- Vendors may have an individual table drawing; however, Vendor is responsible for collecting names and distributing prizes for any individual table drawing.
- **Fee per booth is \$50.** All vendor fees go directly back to Casey's Kids to support KISD students.
- The booth size is approximately 10x10, however, multiple spaces may be purchased.
- Vendors are responsible to bring their own table, pop up tent, tablecloth, generators, and any other merchandise or decorations to make their space inviting.
- There will be no refunds for any reason including weather or any other unanticipated events.
- Please note that we will not have generators or power available, please arrange for electricity if needed.
